1. Privacy Policy

A. Introduction

This Privacy Policy applies to the processing of personal data by Belga Films in connection with its activities, as controller or joint controller of these personal data. A "controller" is a person or organisation who alone or jointly determines the purposes for which, and the manner in which, any personal data is, or is likely to be, processed.

Subject to the information provided in the Cookies Policy (see below), Belga Films does not process any personal data via this temporary webpage.

Notwithstanding the foregoing, the use of the Belga Films social media pages (Facebook - https://www.facebook.com/belgafilms.be/; Instagram - https://www.instagram.com/belgafilms/; Youtube - https://www.youtube.com/user/Belgafilms and Twitter - https://twitter.com/BelgaFilms) linked to this page may involve the collection, exchange and use of certain personal data between these social networks and Belga Films, in particular through the use of cookies. B. Which of the information processed via these social media pages does Belga Films collect or may collect for its own account?

Neither Belga Films nor its sub-contractors store this information in databases of their own. In other words, we only use this information via the social media pages.

Belga Films also has access to information regarding your activity on its social media pages. Concretely, social media provide us with statistics and aggregated insights that allow us to understand how people interact with our posts, ads, pages, videos and other content. For example, we receive, via our Facebook and Instagram pages, information about the number of people or accounts who viewed, commented on, or reacted to our posts, as well as aggregated demographic and other information that help us understand the interactions with our Pages.

Regarding advertising, the social media provide us with reports on the types of people who see our potential ads and on our ad performance. For example, we have access to information such as general demographic and interests information (e.g., an advertisement was seen by a woman between 25 and 34 years old who lives in Madrid and who loves computer engineering) for help better understand our audience. The social media will also check ads that led you to make a purchase or take action with us.

These statistical and advertising data are always rendered anonymous so that Belga Films never has access to personally identifiable information, unless you give permission to the social media.

C. What are the purposes and the legal basis for which Belga Films uses or may use your personal data?

D. Disclosure of your personal data

Law enforcement bodies

Where required, we will disclose your personal data to any person or entity to whom we are required or requested to make such disclosure by any court of competent jurisdiction or by any governmental, taxation or other regulatory authority, law enforcement agency or similar body.

• Service providers

Our service providers and contractors have access to your personal information so that they can perform the services they provide to us, such as execution, creation, maintenance, hosting, service provision, carrying out marketing activities, processing e-mails..., etc. This list is non-exhaustive and may evolve.

E. Data retention

We only retain your personal data for as long as necessary to fulfil the purposes we collected it for. The amount, nature and sensitivity of the personal information, the potential risk of harm from unauthorised use or disclosure of your personal data and the purposes for which we process it and the applicable legal requirements are elements we take into account to determine the appropriate retention period for your personal data. F. Data security

G. <u>International transfers</u>

H. Your legal rights

Under certain circumstances, you have rights under Belgian and European data protection laws in relation to your personal data, and Belga Films will act promptly and in accordance with any applicable law, rule or regulation relating to the processing of your personal data.

Notwithstanding the foregoing, we hereby remind you that Belga Films is joint controller of the personal data that is processed via its social medias pages and that the only personal data we currently process come from your activity on our social media pages and our means of actions on this data may be limited depending on the social media policies. We invite you once again to consult the privacy policies of these social media.

The details of your rights are set out below:

Right to be informed about how personal data is used

You have a right to be informed about how we use and process your personal data, and this explanation shall be provided to you in a concise, transparent, intelligible and easily accessible format and will be written in clear and plain language.

• Right of access

You have a right to obtain confirmation of whether we are processing your personal data, access to your personal data and information regarding how your personal data is being used.

• Right to rectification

You have a right to have any inaccurate or incomplete personal data rectified.

• Right to erasure ("right to be forgotten")

You have a right to request that certain personal data held by us is erased. We will consider each request carefully and on a case-by-case basis, in accordance with law requirements.

• Right to restriction of processing

In certain circumstances, you have a right to restrict the processing of your personal data (e.g. if you are disputing the accuracy of personal data, if you have raised an objection to processing, if processing of personal data is unlawful and you oppose erasure and request restriction instead or if the personal data is no longer required by us but you require the personal data to be retained to establish, exercise or defend a legal claim).

• Right to data portability

In certain circumstances you can request to receive a copy of your personal data in a structured and commonly used electronic format. This right only applies if the processing is based on your consent or if the personal data must be processed for the performance of a

contract and the processing is carried out by automated means. The right to data portability shall not adversely affect the rights and freedoms of others.

• Right to object to processing of personal data in certain circumstances, including where personal data is used for marketing purposes

You have a right to object to processing if (a) we are processing personal data based on legitimate interests or for the performance of a task in the public interest (including profiling), (b) if we are using personal data for direct marketing purposes, or (c) if information is being processed for scientific or historical research or statistical purposes.

• Right not to be subject to automated decisions where the decision produces a legal effect or a similarly significant effect

You have a right not to be subject to a decision which is based on automated processing where the decision will produce a legal effect or a similarly significant effect on you.

We may need to request specific information from you to help us confirm your identity and ensure your right to access your personal data (or to exercise any of your other rights). This is a security measure to ensure that personal data is not disclosed to any unauthorized person. We may also ask you for further information in relation to your request to improve and speed up our response.

We try to respond to all legitimate requests within one calendar month. Occasionally it may take us longer than one calendar month if your request is particularly complex or you have made a number of requests. In this case, we will notify you and keep you updated.
